5. Submission of a PDF copy of the completed bid tender document together with all supporting tender documents must be submitted on a readable compact disc together with the bid at close of tender.
6. Late submissions will not be accepted.
7. Faxed or e-mailed bids are not accepted.
8. Only Bidders registered on the Central Suppliers Database (CSD) will be eligible to submit quotes.
B-BBEE ratings and points will be allocated in accordance with B- BBEE or EME certificate issued by either a verification agency accredited by SANAS. All entities submit A SWORN Affidavit for B-BBEE Points, must also attached a Letter from the Accountant confirming the annual turnover is less than 10 Million or Attached 12 months banks statements (not older than 3 months) or an audited annual financials statement, together with CIPC ownership certificate. No points will be awarded if this condition is not adhered to.
13. The bidder must submit samples of each items on the closing date of tender by not later than 11:00, at the ground floor boardroom.
