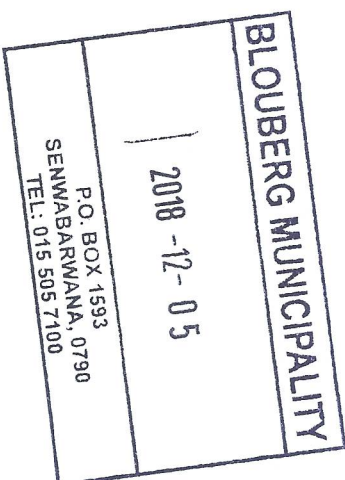
**The following condition will apply:**
